Main responsibilities

The Site Nurse will be responsible for all testing and treatment services, medicine dispensation and keeping stock of all medicines and medical equipment used at the site. He/She will also be responsible for the overall administration, coordination and development of the WBCG Wellness Project in the Karas region by overseeing the implementation of related activities as outlined in the project work plan.

1. Administer Comprehensive treatment and counseling services for clients as per the national and NIP standards, guidelines and protocols;
2. Develop, Implement, Manage and Coordinate the WBCG Wellness Service initiative by liaising with all relevant stakeholders and partners within the region and district;
3. Facilitate the establishment of an effective and sustainable WBCG cross border HIV/AIDS programme.
4. Supervise regional staff and ensure that project activities are conducted and targets are achieved as per project plan.
5. Regularly Monitor and control training records, pharmaceuticals and other systems within the scope of the project.
6. Submit timely monthly, quarterly and annual narrative reports and statistics to the Regional/District Medical Office, and the Walvis Bay Corridor Group respectively.

Requirements

Minimum Education and Professional Requirements:

1. Grade 12 (minimum 20 points)
2. Relevant Degree or Diploma in Nursing and Must be a Registered nurse (registered with the Nursing Council of Namibia).
3. MoHSS Accreditation for HIV Rapid Testing and Counseling
4. At least five (5) years clinical experience and/or experience in the field of HIV/AIDS, Wellness and project management with a minimum three (3) years supervisory experience.
5. Must be able to work independently and under pressure and be prepared to work overtime. Must be a Namibian citizen preferably based in the regions where position is (Good knowledge of the local area will be an advantage).
6. Fluent in English and local languages of the region - fluent in at least one vernacular is a distinct advantage.
7. Must have good knowledge of the policies and guidelines of the Namibian national response on HIV/AIDS.
8. Strong computer skills with functional working knowledge of Microsoft Office applications, Oral and written fluency in English, including good report writing skills.
